OUR PROGRAM OFFERS TWO DISTINCT PROCESSES: THE TRAUMA RESILIENCE PROTOCOL (TRP) FOR TRAUMA AND THE EMOTIONAL MANAGEMENT PROCESS (EMP) FOR NEGATIVE EMOTIONS AND SELF-LIMITING BELIEFS. WE PROVIDE TRAINING TO INDIVIDUALS IN VARIOUS SECTORS INCLUDING ACTIVE-DUTY MILITARY, FIRST RESPONDERS, EMERGENCY MEDICAL PERSONNEL, NATIONAL GUARD UNITS, MILITARY RESERVES, VETERANS, AND MEDICA PERSONNEL. PARTICIPANTS ACQUIRE IMMEDIATE SKILLS TO ENHANCE THEIR RESILIENCE, ENABLING THEM TO EFFECTIVELY COPE WITH TRAUMA AND SIGNIFICANT EMOTIONAL EVENTS. ADDITIONALLY, THEY LEARN HOW TO COACH OTHERS THROUGH SIMILAR PROCESSES. OUR TRAINING INVOLVES ENGAGING IN BOTH THE TRP AND EMP PROCESSES TO ADDRESS PERSONAL EMOTIONS AND TRAUMAS. NOTABLY, THESE PROCESSES DO NOT DELVE INTO THE SPECIFICS OF INDIVIDUALS' EVENTS.

INITIALLY, IT SERVED AS A MEANS TO REINTEGRATE VETERANS BY FACILITATING CONNECTIONS WITH FELLOW VETERANS, PROVIDING A CRUCIAL HUMAN CONNECTION TO A NEW COMMUNITY. HOWEVER, IT HAS SINCE DEVELOPED INTO A FULLY OPERATIONAL COACHING PROGRAM. NOW, VETERANS THEMSELVES ADMINISTER THE TRAUMA RESILIENCY PROTOCOL (TRP) AND EMOTIONS MANAGEMENT PROCESS (EMP) ON A PEER-TO-PEER BASIS.


